Any information provided on this form in relation to Target Retirement Age will be treated with utmost confidentiality by the Trustee.

Lifestyle Strategy – Retirement Focus fund In the last five years before your Target Retirement Age your Retirement Account will move into the Retirement Focus fund. Within this fund there are three different options (see the Retirement Account Guide for details). If you would like to select an option within the Retirement Focus fund you can do this through www.MyPension.com/LEPS. If you do not make a selection your Retirement Focus funds will be invested in the default option within Retirement Focus fund.
